

PRIVACY POLICY

Thank you for visiting Proaktiv PR's website. Just in case you were curious about what we do with the information you provide during your visits to our website, this policy will tell you... so read on!

The information Proaktiv PR collects and how we use this information

Proaktiv PR only obtains information such as your name and email address when you provide it voluntarily. Proaktiv PR uses its best efforts to protect this information and the privacy of its customers. For example, personal information may be collected from you to:

- respond to your comments regarding our website;
- respond to enquiries and applications submitted by you

Sharing of Personal Information

We keep your enquiries and applications confidential. However, we may share personal information within the company and with its affiliated companies. Occasionally, with your permission of course, we will send marketing information to you, such as discounts, information about new product/service offerings, etc. If you do not want to receive this stuff, we will not send it to you.

Proaktiv PR sometimes contacts other companies for a variety of reasons, such as fulfilling orders and assisting with promotions. These companies may have access to personal information if they need it to do their work. However, we will make these companies promise to use any personal information only for the purpose of performing their work.

Proaktiv PR does not sell, transfer or disclose your personal information to any third parties. However, with your permission, we may occasionally send marketing information to you on behalf of one of our business partners. On our website, or elsewhere, we may ask if you want to receive marketing materials from our business partners. If you want to receive this stuff, we'll send it to you... if you don't want it, just tell us and you won't get it. But remember, Proaktiv PR will not share your personal information with any of its business partners. We will just send a mailing or e-mail on behalf of the business partner.

Now for a little legal stuff... our lawyers made us put this in here! Proaktiv PR reserves the right to use or disclose any information as needed to satisfy any law, regulation or legal request, to fulfill your requests, or to cooperate in any law enforcement investigation or an investigation on a matter of public safety.

Access

You are in control of any personal information you give us. If at any time, you want to correct the personal information we have about you, or if you want to change your preferences for contacts from us or on behalf of our business partners, please send us an e-mail or a letter.

Although our website is not intended to collect personal information from kids under the age of 13, to review any personal information that your child may have submitted to Proaktiv PR, to ask us to delete that information or to stop further use of the information, please just let us know.
